As per terms of our PUPGBHO/SECURITY/ RFP / 2022 dated 22-07-2022 floated for supply and maintenance of security gadgets like burglar alarm, Fire alarm, CCTV cameras etc on CaPex and Opex model, a prebid meeting was conducted on 16-08-2022 at Prathama UP Gramin Bank's Head office at Ramganga Vihar Phase II Moradabad.

Based on prebid meeting Corrigendum was sent through mail dated 22-08-2022 and also uploaded on our bank website. Now three bidders like Bhoomi Electronics security and Surbhi Security systems and Sai Security Visions asked their clarification through mail dated 31-08-2022 on following points:

Notes 1, 2 and 3 on page 28 of the RFP describe the OEM and its authorized representatives and Indian representatives/agents and their participation in the system integrator and bidding system. Their participation has been restricted. Necessary equipment is being imported. OEM has offices in India and these offices issue OEM certificates to Agents / System Integrators etc. Whose number can be in the thousands. If participation is restricted then only a limited number of certificates can be issued who can participate in the process. It seems to be limited tender and not tender. Please clarify to enable us to obtain OEM certificate and apply for partnership.</p> <p>In this tender, there was no mention of OEM other than HikVision Dhaua SAMSUNG, so that no one could give us the certificate. And you give us the details of Indian OEM. We need to confirm the decision at the earliest .All these restrictions should be removed.</p>	<p>In this case ,Committee agreed to remove restriction on, maximum two Authorized Representatives /agents/system integrator so that any authorized Representatives /agents/system integrator can take participation in bidding process.</p> <p>However these points were not raised during prebid meeting dated 16 - 08-22</p>

Again we would like to bring your attention to the above points.We have contacted the OEMs but they all have shown their hesitation to provide us the MAF or any kind of authorization until the above clauses remain in the tender.
